VII. DIRECTOR'S REPORT (C. LATIMER)

Mr. Latimer started his report by reviewing some of the successful events that took place over the past month including the 3-day Halloween event, the Modern Warriors film screening, "Stolen People, Stolen Bones, and Stolen Art" hosted by Dr. Paul Hill, a concert by Artist in the Night, a chess tournament, a digital literacy celebration sponsored by the Public Library Association and AT&T, and a book discussion of D.L. Hughley's "How to Survive America".

Mr. Latimer added that the administration team has met about the strategic plan and there will be a presentation later during this meeting. He also added that they are evaluating the possibility of reintroducing Friday services to the community.

Mr. Latimer concluded his report by informing everyone that the Winter Program Guide is now available.

VIII. FISCAL OFFICER'S REPORT (R. COCKFIELD)

Mr. Cockfield read his report that was prepared in November 2023.

Our financials are reconciled with the bank through October 31, 2023. Our reconciled total cash/fund balance at 10/31/23 is \$2,086,706.12. Our General Fund balance \$1,979,018.65. The balance of our Star Account set aside is \$413,146.83.

Year to date revenue is at 103.2% of what we budgeted through ten months. This is because our property tax revenue was higher than budgeted, and grants and donations have exceeded our budgeted expectations.

On the expenditure side, through ten months we're below budget for general fund expenditures showing a 81.1% percent of budget spent as against an 83.3% benchmark.

The board is being presented with a resolution to approve a cost-of-living adjustment of 3.5%. In contrast the Federal Govt. Is giving a COLA of 3.3%. I estimate that the adjustment would increase our current salary costs by approximately \$58,000 over our current level. The increased costs include wages and OPERS retirement benefits.

We've completed our Temporary Appropriations budget and will be presenting it to the Board for approval next month. The Temporary Appropriations establishes our 2024 budget for the first three (3) months of the year at which time we must pass a permanent budget for the balance of the year.

Lastly, I would like to meet with the new board members to go through the financial statements and clarify any questions they might have.

C. <u>Library Services Committee Update (Chairperson)</u>

Ms. Sharpley stated that the Library Services Committee did meet this month and discussed the success of several programs like the Halloween program that was attended by around 400 children. Ms. Sharpley credited the success of that event on the staff's engagement.

There was also mention of the success of ECPL's chess tournament. The tournament attracted the nation's highest ranked 10-year-old who was just ranked as a master.

Ms. Sharpley shared that the Public Library Association's digital literacy celebration of the East Cleveland Public Library's provided free laptop computers to more than 50 people.

Ms. Sharpley also announced a few upcoming events like the November 26th concert by the Band with No Name, a Pop-Up-Shop on December 2nd hosted by the Friends of the East Cleveland Public Library.

Ms. Sharpley concluded her report by mentioning a few upcoming conferences in 2024. The Public Library Association (PLA) will start on April 3rd in Columbus, the ALA it starts on June 22nd in San Diego, the Black Caucus starts on July 24th in New Orleans, the National Book Expo will take place in May at New York city.

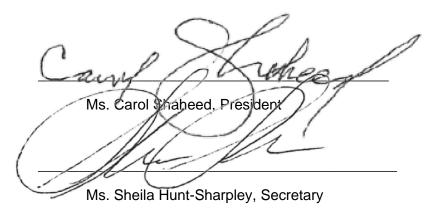
