VI. FISCAL OFFICER'S REPORT (R. COCKFIELD)

Mr. Rashid Having no communications, we'll move on to the Fiscal Officer's

report.

Mr. Cockfield Thank you Mr. Rashid. In the interest of time, I just wanted to point out

some highlights. We have reconciled cash balances as of September 30th of \$1,595,183.60 Our cash balances are steadily increasing. Certainly as a result of prudent operations management by the Director, and just increasing cash balances received from state as a result of the PLF and property tax revenues being more than were projected. We're on target our appropriations are running at 74.9% of our budget, which is where they should be through three quarters of the year. Aside from that we're in very good shape and holding. Additionally, I just want to point out before the board, there's an appropriations increase that we're requesting of \$200,000, over what was originally appropriated in in March of 2021. As a result of the need to increase for our security camera system, improve our flooring,

there's an interest in expanding the carpeting throughout the remainder of the hall here and additional salary changes. So we're requesting the increase of \$200,000. Not necessarily needing it but, feeling that it would be an adequate cushion, given how we want to close the year out.

Mr. Rashid The question I have for you, is that all of the current projects that we

have going on now, the money that you're asking for, in addition, it will

make sure that we cover all of these contingency plans?

Mr. Rashid Yes.

Mr. Rashid Okay. Because I know we changed a few things earlier in the process

with the development of the copy center, and hopefully, all of that equipment should be arriving shortly. But if we've increased, you know, we've been covered that money, we should move forward with the field give us a slight cushion. If anything else you just kind of come out of out of ordinary. But you don't want this to encourage us to

spend more money?

Mr. Rashid No, no, we just want to make sure we have a cushion.

Mr. Mays I have a question in reference to the marquee. Are we still...?

Mr. CockfieldYes. The marquee is still in there.

Mr. Rashid Does that conclusion Finance Officer's report?

 Resolution 10-03-2021: Authorizing the Director of the East Cleveland Public Library for the Public Sale of Computer Equipment and Furniture.

Resolution No. 10-03-2021: Resolution Authorizing the Director of the East Cleveland Public Library for the Public Sale of Computers, Computer Equipment and Furniture.

Whereas, the Director has identified the computers, computer equipment and furniture that is no longer used by the library and asking permission to have a public sale.

Now, therefore be it ordained by the Board of the East Cleveland Public Library's Board four-seventh (4/7) concurring.

Section 1. That the Director herby is authorized to take such actions as in his judgement are necessary to carry out intent and objectives of this resolution.

Section 2. Be it is found and determined that all formal actions of this Board concerning and relation to the passage of this resolution were adopted in an open meeting of the Board and that all such deliberations of this Board and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements.

Section 3. That this resolution receives the affirmative vote for four seventh (4/7) of the Board members, it shall take effect and be in force immediate upon its passage and approval by the Director, otherwise it shall take effect and be in force from and after the earliest period allowed by law. This resolution is also in accordance with the Ohio Revised Code allowing for proper notice to the general public via a newspaper.

Be it resolved, Adoption of Resolution No. 10-03-2021 authorizes the East Cleveland Public Library's Director to publicly sell computers, computer equipment and furniture which are unfit for public use during the time, date and location listed below:

All proceeds of the sale will be deposited into the East Cleveland Public Library's general fund.

what it's going to look like and hopefully the date that we think the

completion will be done, we'll publish that as well.

Dr. Rice I will say for your website that I really enjoy going on there and seeing

all the different things. I think you all are doing a great job.

Mr. Rashid Thank you very much that goes back to listening to the Director and

his team. I think they do a fantastic job as well. I go on there to see what's new myself. Okay, is there any other audience participation at
